This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type The product is in the form of a note issued under English law. It is not an interest bearing security. The payment obligations of the product manufacturer are guaranteed by The Goldman Sachs Group, Inc.

Objectives The product provides the potential for capital growth and does not pay interest. What you will receive at the end of the term of the product is not certain and will depend on the performance of the underlying assets. In addition, you will take the risk that some of the value of your investment may be lost at the end of the term of the product. The term of the product will end no later than July 7, 2027. However, the product may terminate early depending on the performance of the underlying assets. Each note has a face value of CHF 1,000. The issue price is 103.00% of the face value. The product is not listed on an exchange. The issue date is July 7, 2022.

Autocall feature: If the closing price of each underlying asset on any autocall observation date is at or above its autocall barrier, the product will terminate on the corresponding autocall payment date. In this case, you will receive the autocall payment shown below for each note that you hold.

Repayment at maturity:

This section applies only if no autocall occurs as described above.

On July 7, 2027, for each note that you hold you will receive CHF 1,000.00 multiplied by (i) the closing price of the underlying asset with the lowest performance (as compared with its initial reference price) on June 30, 2027 divided by (ii) the initial reference price of such underlying asset. However, if this exceeds CHF 1,000.00, you will only receive CHF 1,000.00 (the maximum payment) and if it is less than CHF 800.00, you will receive CHF 800.00 (the minimum payment). The initial reference price of an underlying asset is the closing price of such underlying asset on June 30, 2022.

These events are specified in the product terms and principally relate to the underlying assets, the product and the product manufacturer. 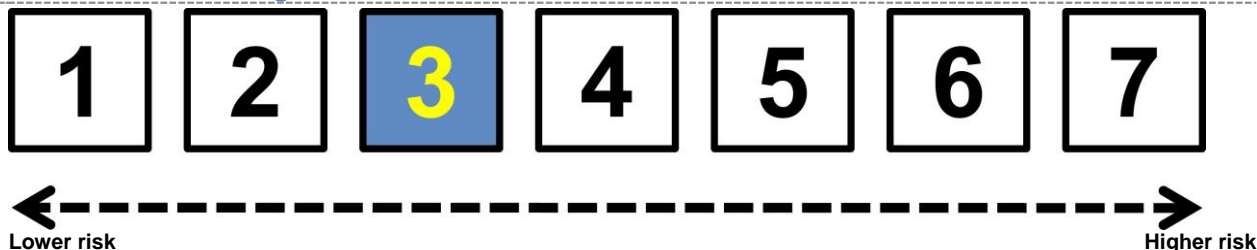
The product is intended to be offered to retail investors who:

1. have the ability to make an informed investment decision through sufficient knowledge and understanding of the product and its specific risks and rewards, with experience of investing in and/or holding a number of similar products providing a similar market exposure;
2. seek capital growth, expect the movement in the underlying assets to perform in a way that generates a favourable return, have an investment horizon of the recommended holding period specified below and understand that the product may terminate early;

- accept the risk that the issuer or guarantor could fail to pay or perform its obligations under the product but otherwise are able to bear a total loss of their investment;
- are willing to accept a level of risk to achieve potential returns that is consistent with the summary risk indicator shown below; and
- are making use of professional advice.

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for 5 years. You may not be able to cash in early. You may have to pay significant extra costs to cash in early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a medium-low level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

You are entitled to receive back at least 80.00% of the face value of the product. Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash in before July 7, 2027. If we are not able to pay you what is owed, you could lose your entire investment.

What are the costs?

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

The recommended holding period for the product is 5 years as the product is designed to be held until maturity; however the product may terminate early due to an autocal or an extraordinary event. You have no contractual right to terminate the product prior to maturity.

The manufacturer is under no obligation to make a secondary market in the product, but may repurchase the product prior to maturity on a case-by-case basis. In such circumstances, the price quoted will reflect a bid-ask spread and any costs associated with unwinding the hedging arrangements of the manufacturer in connection with the product. In addition, the person who sold you the product may charge you brokerage fees when you sell the product back to the manufacturer.
