This product is classified for Swiss tax purposes as a transparent non-Swiss bond-like derivative financial instrument with a predominantly one-time interest payment ("Obligationen-ähnliches Produkt mit überwiegender Einmalverzinsung"; IUP). As a result, the positive difference between the value of the bond floor (in CHF) at the redemption/disposal and the value of the bond floor (in CHF) at the issuance/acquisition of the product is taxable income at redemption/disposal date for Swiss resident individual investors ("Modifizierte Differenzbesteuerung"). The remaining part of the return of the product is tax-free for Swiss resident individual investors holding the product for private investment purposes.
